- NINOS, Inc. is soliciting Bids for bottled drinking water & water cooler rental for facilities located in Cameron and Willacy Counties, or until a subsequent bid is awarded.
- Bottled Drinking Water and Water Cooler Rental will consist of the following:
  1. Furnish and install on Monthly Rental Basis, Bottled Drinking Water Dispensers and Deliver (bi-weekly) Bottled Drinking Water in five-gallon units at various Head Start / Early Head Start facilities.
  2. Current requirements are for sixty-one (62) Water Dispensing Units.
  3. Current requirements are for ten (10) Water Bottle Storage Racks.
  4. Approximate monthly requirements for two hundred-sixty-seven (267) bottles of drinking water in 5-gallon containers. See Attachment "B" for approximate monthly distribution.
- Bids will be evaluated based on the following, not necessarily in order of importance. Evaluation weight may be assigned to each category listed below. Some consideration may be given to those bottled water companies that have industry certification standards with IWBA and or NSF.
  1. Price
  2. Delivery
  3. Bidder references

1.
